Chairman Dempsey:

In the year of our Lord 1776, our Founding Fathers brought forth the Declaration of Independence to free this country from the bonds of tyranny of the British Crown. This declaration is still revered today as one of the most powerful and influential documents ever written. The principles and concepts found in this document along with the *Constitution of the United States of America* and the *Bill of Rights* allowed *our* Forefathers to create one of the greatest nations on earth in a few generations. Our government operated within the confines of these trust agreements until it was changed by a constitutionally unlawful act of Congress on February 21st, 1871, the territory of the seat of government of the original *de jure* Republic, within the District of Columbia, was incorporated with the District of Columbia, forming a new municipal UNITED STATES Government Corporation operating upon the American People as a Democratic, executively administrated municipal corporate government. However, Congress did this without the knowledge and consent of *We the People*. The *Declaration of Independence* and *Constitution of the United States of America* together, make it very clear that Congress DOES NOT have the authority to change our form of governance or our law form without FULL DISCLOSURE and the CONSENT of the People. They simply did not have proper lawful consent of *We the People* to take these actions in 1871. Our system of law was changed to a *Legal* system that has slowly eroded away the very fabric of the American society by functioning as if our lawful Constitution is irrelevant. We are now a nation under the threat of

Socialism/Marxism. All of this was done without the CONSENT of *We the People*. In Washington D.C. there is a Congress and an unlawful President that has no regard for the law, and brought America to the brink of total financial and moral ruin. The total collapse of our society is inevitable unless we change things NOW. We believe most of these unlawful representatives are committing treasonous acts against the American People daily.

I am writing this letter to the Joint Chiefs in an effort to help save America and future generations of the American People. What is going on in Washington is not by the will of, or by the consent of the People.

On March 30, 2010, a group of a few thousand men and women representing the will of the nation stood up in lawful assembly and said, "Enough is enough"¹. A declaration was sent to the governors of all fifty States ordering that they return to following the Supreme Law of the Land, which is the *Constitution of the United States of America* and the *Bill of Rights*. This was an attempt to stop all unlawful acts being forced upon *We the People* against our will and consent. You may say that only a few thousand people stood up in March of 2010, but only 56 of our Founding Fathers began the movement in 1776. Our declaration was ignored and we sent another notice July 20, 2010, which was also ignored.

By ignoring our Declaration and notice, the elected officials of the UNITED STATES municipal corporation have placed the UNITED STATES corporate government into a serious constitutional breach of contract of their fiduciary duties and the Oaths of Office, which they are sworn to uphold. Anytime that a lawful remedy for a breach of duty is requested and that request is ignored, a default in law occurs. The party requesting the remedy now has the right to choose and bring forth their lawful remedy because of the default of the opposing party. The remedy that we chose was to *peacefully* re-inhabit the original organic *Republic of the United States of America*. This has been lawfully completed and is fully documented. It is our intent to work hand in hand with those who understand the problem and want to correct it

I believe there are many within the US corporate government who would work with us at this time, given the safe opportunity. As President of the Republic, it is my intent to offer the military leaders all of the lawful authority needed to perform the duties that are necessary to bring about this re-integration. I need information from you to make that happen. We have a documented lawful Republican form of government structure and are the only lawful Civil Authority in this nation. *We the People* have a higher authority than the UNITED STATES municipal corporation in law and in fact. We do not have the ability to enforce that authority; therefore we are calling upon you for that enforcement. I, by the consent of *We the People*, offer this authority to our military leaders to help us accomplish this task.

On September 23, 2010, *We the People* cast a lawful vote by the delegates from a lawful quorum of 42 free states, to reinstate the Executive, Legislative, and Judicial Powers of the reinstated Republic. Pursuant to the Constitution, the one Supreme Court was reinstated and Supreme Court Justices were sworn into office. Again, this was accomplished by the consent and votes of *We the People*. This action is lawfully supported by the *Declaration of Independence* of 1776. Our lawful Republic is in place and in full compliance and moving forward. I was elected as the lawful president by a 94% majority vote of *We the People* of this re-inhabited Republic of the United States of America. I am a lawful American by birth and legally qualified to be the lawful President, in the interim, until *We the People* are able to hold lawful national elections as established by our constitution. We have prepared a detailed 17-step plan that can re-integrate the lawful Republic government into our society without disruptions, unrest, or civil war. Our plan allows us to make a peaceful transition that will restore the United States of America to its proper place among the nations of the world.

I hereby formally request that the Joint Chiefs and the Military of this nation stand with us to recognize and re-integrate the Republic of the United States of America as the lawful government in and for America. I, as President, under the direction and authority of *We the People*, who are the lawful Civil Authority, do hereby request the United States Military Joint Chiefs of Staff to lawfully act upon on behalf of the People of the lawful Republic for the United States of America. We wish to meet discretely with a few select Republic officials and talk in a manner that is safe and secure for all parties involved. This letter has not been revealed to any other source.

For decades, the officers of the UNITED STATES CORPORATION who have unnecessarily put our soldiers in harm's way have held the military in low esteem. The intent of the Republic is to return the control of the military back to the military leaders. Politicians should not be making decisions for the military. We are committed to restore the status of the military to its rightful place. In times of national emergency, we want it to be our military leaders who create and implement the strategies to successfully return our nation to peaceful conditions.

We are a peaceful people who do not wish any conflict, but without your support we understand what the consequences could be. We do not believe that the American military men and women of this country are pleased with what is happening in Washington any more than *We the People* are. We also believe that given an alternative to the current *de facto* corporate regime, the military would choose to do what is right for America. We are now giving you that lawful choice.

We the People are of the opinion that financial collapse of our beloved nation is eminent according to many financial sources from around the world. We have a plan and the resources that will bring peace, stabilize the economy, and restore America to its rightful place as the greatest nation on earth. We believe the collapse was planned with the intent to bring America down to her knees and destroy it from within.

We are appealing to your Patriotism and love for America to help us stop the usurpations of freedoms of *We the People*. I will stand for America no matter what the consequences may be. I love my country and the American people. I would gladly sacrifice all with no regrets but would rather live in peace and prosperity and enjoy it. I, together with most of the people of America, will gladly support and applaud your actions to remove any foreign or domestic terrorist threat as you see fit. This is a necessary action in order to re-establish and protect a lawful Republican form of government, which is truly of, by, and for the people of the free Republic for the United States of America.

We are a peaceful people who abide by the laws of our creator, namely to love God and love our fellow man. We wish no harm upon any man, but *We the People* of the Republic will stand with our great military to protect our nation. Our prayer is that you as the brave and honorable men and women of the military of the United States of America will come forth and deliver your beloved nation from this tyranny from within our borders. May God the Creator guide you in your decision to defend and protect America and her People. Peace to you all, and God Bless America.
