NOTICE TO THE SUPREME COURT OF THE UNITED STATES

On July 4th in the year of our Lord 1776 the founding fathers of America adopted the Declaration of Independence in Philadelphia, Pennsylvania. This declaration began an arduous task by our Fathers to create a nation. Many pledged their wealth, honor and even their lives for the cause for our liberty. Their dedication, wisdom and sacrifice helped form the Greatest Republican form of governance ever conceived. The United States of America is a nation of *We the People*; Sovereign People, who are equal to kings but without subjects. The United States of America was a representative type Republic form of governance in which the elected officials would *Serve* the Public on their behalf; by *Consent*. When one of the People is elected to any office they become Public Servants with limited delegated authority of the People. This Republic system of governance of,

by and for *We the People* brought this fledgling nation to the status as a world power in less than 100 years.

Financial and political struggles were created by deception between the northern and southern states inflicting a civil war. This war promulgated the agenda of the bankers of Europe. These seeds of deception lead to infiltration of key positions which placed their pawns (*trusted men*) within the American government with an agenda to take advantage of the People of the United States of America.

Covertly, a political party democracy replaced the *de jure* republic form of governance allowing the *de facto* congress to pass laws that allowed banks, corporations and other foreign entities to steal the wealth, land and property from *We the People*; by enriching, manipulating and coercing the elected officials. These corporate entities eventually took unlawful control of the United States of America and its People. The *de facto* congress that was now in the employ of international bankers slowly, methodically and carefully changed, manipulated, deleted and abolished or shelved many laws. They did this quietly while controlling the news media to keep *We the People* from finding out about their dark deeds. The legislative, executive and judicial branches methodically controlled and modified the law to keep their activities covert. Anyone who questioned or figured out what was happening was suppressed, incarcerated or eliminated. Some were threatened; some received long prison sentences on contrived crimes, while others were even murdered to cover up the plan. Ultimately, these international bankers, who were entrusted with a fiduciary responsibility, have taken complete control of nearly every facet of the American People's lives. The international bankers control the content and flow of information that we see and hear in almost every form. They control the availability of goods and services in order to control prices. They control public education in order to keep the public at a programmable and controllable level. The intent is a socialist agenda and herd mentality. Chemicals such as chlorine and fluorine have been introduced into our municipal water systems in order to keep the masses weak, docile, non-violent and controllable. Our children have been forced to receive government sanctioned vaccinations laced with Thymerisol, *et al.* Research has proven

these chemicals are known to cause autism and other health defects. *We the People* continue to be harmed and impaired through our food, water, air, medicine, and education.

Private organizations in conjunction with federal agencies are used to promote genocide of many peoples. They use the *de facto* congress and judiciary to create and enforce codes, regulations and ordinances for the purpose of controlling the masses. According to research, more people are killed annually by FDA approved medications than any other source including wars and automobile accidents. Inventors are threatened, coerced and killed to prevent the release of life enhancing/saving devices. Earnings are controlled to keep *We the People* working so hard to survive that we don't have time to think, plan, or enjoy the fruits of our labor. Fundamental aspects of our lives are being controlled in advertising and entertainment; cost of goods, education, media, money, wars, religion and manipulation of our thought processes. The corporations do this at the "Wink and Nod" of the officials in the legislative, executive and judicial branches of the UNITED STATES *de facto* government. *We the People* are not completely asleep. We are now awake, have learned the truth and *We the People* are standing up to implement the *lawful* solution.

Many years have passed since our Republican form of governance was unlawfully converted to a democracy. The democracy that was created has been operated and manipulated by bankers and attorneys for decades. They created a "Legal System" that is used to avoid, usurp, deny, and override the Law of the Land. The legislative, executive, and judicial officers have violated their oaths of office to *We the People*. U.S. congress which is primarily made up of these bankers and attorney pawns have unlawfully ignored The Supreme Law of the Land, and replaced it with this unlawful legal system. The Declaration of Independence is very clear that our leaders only have authority to act upon the *consent* of *We the People*. The elected officials who were and are still under the employ of the international bankers did not ask *We the People* if they could change our governance or our law form without our knowledge. *Lawful consent* cannot be given in the absence of full disclosure. *We the People* never received full disclosure therefore,

lawfully rendering any implied *consent* Null and Void. *Lawful consent* simply cannot be obtained through subterfuge and deception. The True Bible, Declaration of Independence, Constitution of the United States of America, and the Bill of Rights are the lawful law forms on this Land. The elected and appointed officials in office do not and will never have the authority to change this fact in law. The change in our law form has created a vacuum that is devoid of positive law in favor of an unlawful legal system.

In the years 1861-1882 *de facto* congress created a municipal corporation named, The District of Columbia. It was given a lawful jurisdiction of 10 (Ten) miles square or 100 (One Hundred) square miles. This is known today as the UNITED STATES. By lawful congressional definition the UNITED STATES is the District of Columbia, its territories and purchased; Forts, Magazines, Arsenals, Dock-Yards, and other needful Buildings. The law also defines where those territories are and it does not include any of the 48 contiguous states within the territorial boundaries of the United States of America. This is a concern due to the fact that the UNITED STATES, a municipal corporation, unlawfully exercises complete and total authority and jurisdiction upon all of the states and the People within. They do this by a series of rules and regulations that although are not lawful, may be semi-legal due to the implied *consent* of *We the People*. Many of the rules and regulations that are *Color of Law* and not positive law are contrary and in violation of our Laws of the Land, i.e. the True Bible, Declaration of Independence, Constitution of the United States of America, and the Bill of Rights.

This is formal NOTICE that *We the People* are officially revoking any implied *consent* in any and all forms that empowered the UNITED STATES municipal corporation to enslave *We the People*.

A few years ago a select group of *We the People* began to protest to *de facto* law enforcement and illegitimate courts, with the knowledge that our God given unalienable rights had been and are being violated. Since that time we have appeared before your courts, justices, and magistrates, attempting to get justice, only to find that justice does not exist in your system. We have been violated, denied, refused, falsely imprisoned and

treated with contempt by *de facto* law enforcement and judicial officials at every level. We have been falsely labeled terrorists and accused of violence even, when no violence occurred or was planned. We have been personally attacked by the media and accused of many lies. Most of us who are being slandered have never been arrested, convicted or even accused of committing a crime. In fact, we are proud lawful Americans and many of us have worked with the military and law enforcement protecting this country and others from the criminals. We have worked diligently to keep an honorable name as our Fathers and Grandfathers did before us, only to be demonized by *de facto* law enforcement, justices, media, officials, and are improperly adjudicated by your unlawful legal system.

As a result of this continual abuse of justice we have been denied remedy thousands upon thousands of times collectively. The court system is working with the bankers to steal our lands, homes, freedoms and properties even now. We have proven repeatedly that the bankers are committing fraud upon the courts and even with documented proof we have been denied justice at every level. In law, when refused a lawful remedy or resolution that is guaranteed to us by the Constitution and the Bill of Rights, we have the *lawful* right, duty, and obligation to create our own remedy or resolution. We are *lawful* contributors, and peaceful, productive members of society and we seek truth and justice.

The 2nd paragraph of the Declaration of Independence commands, "*That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness...*", thus we are obligated by duty to honor our Founding Documents.

We the People have created that *lawful* resolution and this is **NOTICE** to you, THE SUPREME COURT OF THE UNITED STATES, that we have formally abolished the *de facto* UNITED STATES municipal corporate government, and all of its subsidiaries and subdivisions, by a lawful vote of the Republic Congress.

On March 30, 2010, *We the People* from the 50 states of America sent notice to *de facto* elected officials in the form of a new Declaration of Independence. *We the People* from all fifty states discovered that no legislation has ever dissolved or abolished the original Republic form of governance that was created by our Founding Fathers. We also discovered that the *de facto* government in the District of Columbia was created from fraud and deceit from its earliest beginnings without the *consent* of the governed, *We the People*. We realized in law that the UNITED STATES was a municipal corporate democracy and was never intended to be the Republic form of governance as our founders or People intended. *We the People* found that many treaties and documents support the fact that when we feel the existing government is destructive to the People, we have the authority to abolish it and create a government that provides protection for the basic God-given rights as outlined in our original Constitution c. 1791. The Declaration and Notice that was sent to the 50 *de facto* state governors was our attempt to restore our nation with a government that operates by *Rule of Law* and not *Law of Rules*. Our notice was denied and *We the People* were demonized and accused by the news media. This was to our favor. When our remedy was denied, their actions re-enforced our *lawful* standing to re-inhabit the *de jure* Republic government of the United States of America. Re-inhabitation of the *de jure* Republic is our remedy. *We the people* have completed and fully documented this process. We have a lawfully documented quorum of states. The states have held elections and have elected an interim Congress and a President. We have *de jure* States and Governors, Governor's Cabinets, Constitutions, President's Cabinet, Treasury, Post Office and a Court system of our own. We are moving forward by acts of our Congress. This letter is to notice you that *We the People* are no longer under your jurisdiction, authority and control. Any man or woman who enters your court and claims, by any means, they are sovereign or documented member in good standing of our Republic is to be turned over to our Law Enforcement and Court system without hindrance or delay. If any official, officer, contractor, justice, judge, clerk, bailiff, marshal, or any other such employee at any level that fails to release our People into our custody as requested we will call upon the International Criminal Courts to prosecute them for denying *We the People* our God-given unalienable rights. We are no longer coming as John Doe citizen, we are coming as *We the People*, of the

United States of America as a Nation of Sovereigns. Our *de jure* government will exercise its *lawful* right to protect our People in any lawful and peaceful way. We are not threatening violence, but we will use every possible *lawful* method to protect our People from this day forward. We will send our Rangers to secure our People in their persons, houses, papers and effects in every *lawful* way.

It is our intention to make this positive change for our People as seamless as possible. We do not want to hinder the UNITED STATES in dealing with its citizens as long as they are voluntarily their citizens. We will only involve ourselves in the affairs of those who request to be aligned with us through honest contract agreement with full disclosure. We would like to work closely with you to make the United States of America a better place for everyone. The choice is up to you as we are willing to work peacefully beside your officers, agents, and officials. It has been assumed by some, that *We the People* are coming forward to exact and deliver revenge. This is not the case with the People of the Republic. We have unanimously agreed to practice the higher qualities of our Creator and forgive those who have trespassed against us. We only wish to live in peace with our fellow man. There are those in the "*Sovereign*" community that do not agree with our policy of peace and forgiveness and we do not condone or practice their ideology.

We would like to work as a liaison to effect peaceful change and avoid violence. Many of the People in America are warriors by nature. We in the Republic understand that if we resort to violence that no one will really win, we will all lose. With the exception of a few absolutely wicked People who have been born or bribed into leadership roles, we believe most Americans working in the government want the same things that we do. Education, not violence is needed to restore our beloved country to its place as a true benevolent superpower, as the Creator intends us to be. When we succeed we will return to the awesome abundant blessings of the Almighty Creator. We will no longer be a borrower. We will be a lender to the world and we shall receive abundant blessings for helping others. This is the vision of the People of the Republic for America. We have progressive plans that address every aspect of American life to *secure "life,*

liberty and the pursuit of happiness.” This remedy and resolution has been implemented. We invite you to be a constructive part of this great new government. Together we will succeed because it is the will of the Almighty Creator to restore our great nation and its People to our proper place among the nations. We hope you will join us in making this happen.
